COVID-19 Winter Program Agreement

I understand that the health and safety of participants and staff at Chester Bowl depends on my truthfulness and ability to recognize signs and symptoms of COVID-19 being experienced by myself and/or members of my household.

I agree that I will be well informed about what the symptoms of COVID-19 are. These symptoms include: runny nose, coughing, sneezing, sore throat, body aches, chills, and a fever of 100.4 degrees or higher.

I agree that if any member of my household is experiencing symptoms associated with COVID-19 or has had exposure to someone with a positive COVID-19 diagnosis I will keep my family home and will not attempt to participate in any aspect of Chester Bowl programming until 72 hours after symptoms have subsided or a negative test result has been obtained.

I agree that while at Chester Bowl, my family will follow all COVID-19 related rules that include but are not limited to:

1. Wear a mask or face-covering when indoors or within 6 feet of others while participating in programming while at Chester Bowl. Masks are always required while in the lift line, riding the chairlift, or participating in Freestyle Fridays or lessons.
2. Maintain social distancing of at least 6ft when possible.
3. Wash hands after use of bathrooms.
4. To not hug or shake hands with others, and not to share food or drink with others.
5. Use the Thom Storm Chalet Space only in the event of an emergency or for the use of restrooms.

I understand that my ability to understand and follow the different parts of this agreement is crucial and that it is my responsibility to educate my family about these rules. I understand that if I or my family choose to not follow this agreement the Chester Bowl Improvement Club reserves the right to limit my participation.

I understand and accept that alpine skiing and snowboarding in its various forms is a HAZARDOUS SPORT that has many dangers and risks. I realize that injuries are a common and ordinary occurrence of this sport and that severe injury, including death, is an inherent risk of skiing/snowboarding. I expressly assume all risk associated with skiing and/or snowboarding including without limitation, the risks and inherent dangers associated with skiing/snowboarding and riding the lifts. These risks include, but are not limited to, changes in terrain, weather and snow surfaces, changes in lighting conditions, ice, moguls, snow mounds, snowmaking equipment, bare spots, debris, fences, posts, trees, lift equipment and towers, rope tows, light poles, signs, buildings, roads and walkways, ramps, half-pipes, padded and non-padded barriers, jumps, rails, boxes, and other terrain features, grooming equipment, snowmobiles, utility or all-terrain vehicles, loading, riding and unloading lifts, collisions with other persons and other natural and man-made hazards and slips and falls on ice and snow. I agree to follow, and be bound by, Your Responsibility Code.

In consideration of being allowed to use the area facilities and premises at Chester Bowl, and specifically in exchange for the opportunity to purchase a season pass at Chester Bowl **I agree to release the Chester Bowl Improvement Club**, and its agents, employees, directors, officers and shareholders **from any and all liability for personal injury, death or property damage** which results in any way from negligence, conditions on or about the premises and facilities, the operations, actions or omissions of employees or agents of the area, or my participation in skiing, snowboarding or other activities at the area, accepting myself the full responsibility for any and all such damage or injury of any kind which may result.

To the extent I am signing on behalf of a **minor**, **I hereby release the Chester Bowl Improvement Club from any and all liability for personal injury, death or property damage** sustained by the minor which results in any way from negligence, conditions on or about the premises and facilities, the operations, actions or omissions of employees or agents of the area, or the minor's participation in skiing, snowboarding or other activities at the area, accepting myself the full responsibility for any and all such damage or injury of any kind which may result.

I further agree to **defend, indemnify and hold harmless the Chester Bowl Improvement Club** from any and all claims, demands, losses, damages and liabilities, contribution or otherwise with respect to **personal injury, death or property damage arising from my or a minor** on whose behalf I signed, participation in skiing, snowboarding or other activities at Chester Bowl. I promise not to sue the Chester Bowl Improvement Club and further agree that if anyone is physically injured or property is damaged while I am engaged in any activity at Chester Bowl I will have no right to make a claim or file a lawsuit against the Chester Bowl Improvement Club. I agree to defend and indemnify the Chester Bowl Improvement Club for any and all claims, including subrogation and/or derivative claims brought by any third party or insurer, which I may cause.

In accordance with Minnesota law, nothing in this Release of Liability should be construed as releasing, discharging or waiving any claims I may have for conduct that constitutes greater than ordinary negligence on the part of the Chester Bowl Improvement Club

This Release of Liability is governed by the Laws of the State of Minnesota and is intended to be interpreted as broadly as possible. If any part of this agreement is determined to be unenforceable, all other parts shall be given full force and effect.

Chester Bowl Rental Agreement and Release of Liability – Read carefully before signing.

1. I understand and accept that alpine skiing and snowboarding in its various forms is a HAZARDOUS SPORT that has many dangers and risks. I realize that injuries are a common and ordinary occurrence of this sport and that severe injury, including death, is an inherent risk of skiing/snowboarding. I expressly assume all risk associated with skiing and/or snowboarding including without limitation, the risks and inherent dangers associated with skiing/snowboarding and riding the lifts. These risks include, but are not limited to, changes in terrain, weather and snow surfaces, changes in lighting conditions, ice, moguls, bare spots, debris, fences, posts, trees, lift equipment and towers, rope tows, light poles, signs, buildings, roads and walkways, ramps, half-pipes, padded and non-padded barriers, jumps, rails, boxes, and other terrain features, grooming equipment, snowmobiles, utility or all-terrain vehicles, loading, riding and unloading lifts, collisions with other persons, and other natural and man-made hazards and slips and falls on ice and snow. I agree to follow, and be bound by, Your Responsibility Code promulgated by the National Ski Areas Association and posted at this ski area.

2. I agree to **release the Chester Bowl Improvement Club**, and its agents, employees, directors, officers and shareholders **from any and all liability for personal injury, death or property damage** which results in any way from negligence, conditions on or about the premises and facilities, the operations, actions or omissions of employees or agents of the area, or my participation in skiing, snowboarding or other activities at the area, accepting myself the full responsibility for any and all such damage or injury of any kind which may result.

ALPINE SKIING: I understand that the ski boot/binding system will not release at all times or under all circumstances, that it is not possible to predict every situation in which the system will release and the system is no guarantee that the user will not be injured.

3. I agree not to transfer any part of this skiing equipment to any other user. In the event I do transfer any part of the equipment in violation of this agreement I agree to indemnify the Chester Bowl Improvement Club against any claim, demand, losses or damages arising out of the injury or property damage through use of this equipment. I accept this equipment “as is.” I have been truthful in giving my height, weight, age and ability.

4. To the extent I am signing on behalf of a **minor**, I hereby **release the Chester Bowl Improvement Club from any and all liability for personal injury, death or property damage** sustained by said minor which results in any way from negligence, conditions on or about the premises and facilities, the operations, actions or omissions of employees or agents of the area, or the minor’s participation in skiing, snowboarding or other activities at the area, accepting myself the full responsibility for any and all such damage or injury of any kind which may result.

5. I further agree to **defend, indemnify and hold harmless the Chester Bowl Improvement Club from any and all claims, demands, losses, damages and liabilities** with respect to **personal injury, death or property damage** arising from my or a **minor** on whose behalf I signed, participation in skiing, snowboarding or other activities at Chester Bowl. I agree to return all rental equipment during equipment return nights in clean condition to avoid any additional charges, and I will be responsible for the replacement at full retail price of new equipment to the Chester Bowl Improvement Club for any loss of damage other than reasonable wear resulting from use. **I understand that if I do not contact Chester Bowl staff to make other arrangements or return equipment during the following equipment return nights then my family may not be allowed to participate in future programing, my family will be disqualified from getting our volunteer deposit back and my family will be disqualified from being drawn first during the 2021/2022 Lottery.**

PEACE IN THE PARK AGREEMENT

To be read to or by younger kids:

Chester Bowl should be a safe place for everyone. To help that happen, I promise to be kind and caring to others.

I know that people will be kind and caring towards me. I will tell an adult if I feel that anything bad or unsafe is happening to me, or if I see bad or unsafe things happening to someone else.

By writing my name I promise to follow Peace in the Park.

To be read by older participants:

At Chester Bowl, we believe that everyone has the right to participate in our programs in a safe, peaceful, caring environment where each person is respected. We believe in resolving conflicts without yelling or fighting and being a place where everyone can feel comfortable and safe. We believe that each participant has the responsibility to do everything they can to create this environment at Chester Bowl. We expect the people in our programs to welcome each other, watch out for each other, and demonstrate caring towards each other.

At Chester Bowl we do not allow abuse or harassment of any kind, including verbal abuse (name calling, inappropriate language); physical harassment or fighting; touching others in ways that makes them uncomfortable; harassment or teasing based on religion, race, color, gender, age, ability, sexual orientation, or any other similar category; sexual harassment; or demonstration of lack of respect for another person. If anyone in our programs is treated in those ways by others, or sees them happening to other people, they should tell a Chester Bowl worker about it right away. It is not OK, and we need your help to keep Peace in the Park!

Consequences for violating the principles of Peace in the Parks can include warnings, loss of program privileges (being able to participate in winter and/or summer activities) for part or all of the day, involvement of parents/guardians, and loss of privileges for longer periods of time including the entire season.

VOLUNTEER COMMITMENT

Volunteers make the Chester Bowl Winter Program a successful community program- we couldn't do it without you! We need your help to keep Chester Bowl going. As a volunteer, it is critical that you follow through with your commitment. Please read through and sign this commitment form.

1. I understand that when I sign up to volunteer for a specific time slot and/or activity- such as working the concession stand, serving as a race gatekeeper, etc.- I am responsible to fulfill that commitment. If I am unable to do so, *I will arrange for a replacement*. I know that tips on how to do this are listed on the volunteer tab of our website, chesterbowl.org. As a last resort, I would call the Chalet to report needing to miss a volunteer shift.

2. I understand that two people from the same household should be very careful about signing up to work the same time slots during the same activity. I know that if any family plans, sicknesses, or emergencies come up that would impact our ability to volunteer, causing a double cancellation, it would be very difficult for Chester Bowl to fill multiple openings. If I find myself in this situation, I will find shift replacements for all volunteers.

3. I will remember to record my volunteer hours! I know that the file box holding each family's volunteer card is located on the counter behind the concession stand, and that I am responsible for recording my volunteer hours as I fulfill them.

4. Chester Bowl is committed to maintaining the safety of all of its participants, especially children. I understand that volunteers should never be alone and unobserved with a child that is not their own, and that no volunteer roles require this. I will make sure not to put myself in this situation. If I see another volunteer alone with a child, or notice any other questionable situations, I will immediately inform Chester Bowl staff. If I notice anything concerning with any Chester Bowl staff, who should also not be alone with children, I know I can reach out to Management staff (Sam Luoma and Dave Schaeffer) or to the Board of Directors, and that Board contact information is at the chesterbowl.org web site.

5. I understand that I must complete my family's volunteer commitment to be eligible to have my volunteer deposit refunded at the end of the season. I understand that new families and families who complete their volunteer hours will be drawn at next years lottery ahead of families that did not complete their volunteer hours.
